



55th T.S.B.A Convention Minutes

President Glenn Spack called the meeting to order on June 9th, 2012 at 10:00 am in Alliance, Ohio. An invocation was delivered followed by the Pledge of Allegiance and a moment of silence for members of the league that have passed away since the last convention. Delegates were reminded to sign in on the convention register.

Glenn Spack appointed Joe Noll to act as Sergeant-At Arms.

Roll call of Officers:

Statistical Secretary – CJ Schmitz (present)

Trustees – Hazel Tennis, Debbie Tomusko, and Monica Gilles (all present)

The roll call of delegates showed 9 men and 9 women present and registered to vote, along with 2 guests present.

President Glenn Spack waived the reading of the minutes from the 54th Annual T.S.B.A Convention. There were no objections.

President Glenn Spack gave his report for the 2011-2012 season; he also read Vice President Tom Simon's report. Secretary/Treasurer Jenny Miller and Statistical Secretary CJ Schmitz also gave their reports. Monica Gilles gave the Auditors report, which found the records to be in good order.

Joe Noll made a motion to keep all Honorariums and Allowances the same. Hazel Tennis seconded the motion. All were in favor. Motion carried.

CJ brought to attention that there was nothing in the rules about tournament compensation. He asked for a rule to be implemented to clarify tournament compensation. Sharon Edwards made a motion that the tournament is a separate stand-alone feature of the league, that it is not part of the regular season. Monica Gilles made a second to the motion. All were in favor. Motion carried. Joan Miller-Malue made a motion that only a flat fee of \$75 for tournament duties should compensate each the Secretary/Treasurer and Statistical Secretary. A second was made by Sharon Edwards. All were in favor. Motion carried.

A motion was made by Debbie Tomusko that Doubles be bowled first followed by Singles during the T.S.B.A. tournament. Monica Gilles made a second to the motion. All were in favor. Motion carried.

Debbie Tomusko questioned what we are going to do about teams that do not come back this year, since last year it was established that teams would follow

a set bowling schedule for four years. It was decided that the schedule will stay the same for now, but if there were any conflicts when the entry forms are turned in then CJ will decide the team number of any new teams.

CJ made a motion to set a permanent due date of August 15th for season bowling entries. Barb Noll seconded the motion. There were 17 in favor and 1 opposed. Motion carried.

Debbie Tomusko motioned that teams should be able to choose a name rather than just being assigned a number after the name of the city. It was determined that there was nothing in the rules that said teams could not choose their own name.

Branch Representatives were set for the 2012-2013 season. The list of Branch Representatives is to enable any bowler to contact them during the year to make any changes in meal reservations or bowling schedule.
